(Nashville, Tennessee, March 17, 2018) -- Teams of 6th, 7th and 8th grade student Mathletes from public, private, and parochial middle schools, junior high schools, and homeschools across Tennessee competed in the Tennessee state-level competition of the national MATHCOUNTS program on March 17, 2018, at the Tennessee Engineering Center in Nashville, Tennessee. The Tennessee MATHCOUNTS regional and state contests are organized and sponsored annually by the local chapters of the Tennessee Society of Professional Engineers and by the Tennessee Engineering Foundation. A total of 19 schools and 47 students from across Tennessee, winners of their local competitions in February, competed at the state-level competition. Teachers and students had prepared for this competition since the beginning of this school year. Students competed individually and as teams in written and fastpaced oral matches. Subjects included probability, statistics, linear algebra, and polynomials. Winners of the individual, team, and oral lightning "Countdown Round" competitions received awards and trophies. The State Team will compete at the National Competition at the Renaissance Washington, Washington, D.C. on, May 12-15, 2018. The team will be comprised of George Zhang (Memphis University School); Alex Wang (Montgomery Bell Academy, Nashville); Kerry Zhao (Memphis University School); Franklin Zhang (Tullahoma East Middle School); and Team Coach Meredith McFarlin (Memphis University School).



# NSPE Successfully Champions Federal Legislation to Strengthen QBS Requirements

NSPE successfully advocated for the inclusion of an important provision in the Federal Aviation Administration Reauthorization Act of 2018 (H.R.4) to strengthen Qualifications Based Selection requirements for airports. NSPE and other engineering and construction associations sent a letter to Bill Shuster (R-PA), chairman of the House Committee on Transportation and Infrastructure, urging the incorporation of a bipartisan amendment offered by Rep. Bruce Westerman, PE (R-AR) and Rep. Daniel Lipinski (D-IL). The Westerman-Lipinski amendment clarifies existing rules to ensure that airports follow a uniform QBS process for airport projects that use Airport Improvement Program funds. "[E]ngineering and design are highly skilled, multi-disciplined professions whose services directly affect public safety and welfare. Firms provide technical expertise, innovation, and the latest technologies - skills that are the most important factors in enhancing project performance and cost savings. QBS ensures that these attributes are emphasized in the procurement process. The amendment would expand existing requirements to cover any airport project that uses federal AIP program funds at any stage."

As a result of this initiative, the amendment was incorporated into the legislation. The House of Representatives approved the FAA reauthorization on April 27 by a vote of 393 to 13. The focus now shifts to the Senate where companion legislation is being drafted.

# Mississippi Litigation Has Significant Implications for Use of the Term "Engineer"

Current litigation in the federal courts in Mississippi involving a company calling itself "Tire Engineers" provides NSPE an opportunity to actively assert and advocate in federal court its longstanding policy and position that the misuse of the term "engineer" by unqualified and unlicensed individuals or companies is misleading and deceptive and endangers the public health and safety. A positive outcome in this matter could influence other states' actions on the misuse of the term "engineer." In 2017, NSPE was contacted regarding pending litigation in which the Mississippi Board of Licensure for Professional Engineers, with the assistance of the Mississippi attorney general, sought to challenge an auto maintenance/tire company for using the business name Tire Engineers. The company did not engage in the practice of engineering and did not employ professional engineers in rendering its services. At the time, NSPE provided support to the Mississippi attorney general's office in researching this issue. After negotiations broke down between the state of Mississippi and the company, Tire Engineers challenged Mississippi's position and filed a declaratory judgment complaint in federal district court in Mississippi.

The federal court concluded that the company's use of the business name "Tire Engineers" violated the Mississippi PE statute because the name was inherently misleading/ deceptive. The court also rejected Tire Engineers' commercial free speech and Lanham (trademark) Act claims. In its findings and conclusions, the federal court determined that there was clear evidence that Mississippi consumers were being misled/ deceived by Tire Engineers' use of its business name. The court noted that tire engineers are an actual and recognized group of gualified engineers working to design tires in the transportation industry and that, based upon the survey evidence, Mississippi consumers were being misled as to whether Tire Engineers used qualified tire engineers to perform company services and whether Tire Engineers was actually offering engineering services and/or performing its work with the level of skill and training of a qualified engineer.

Tire Engineers has appealed the federal district court's decision to the US Court of Appeals for the Fifth Circuit. The Mississippi attorney general has requested that NSPE file a "friend of the court" brief in the case in support of the Mississippi Engineering Society. The NSPE Board of Directors is actively considering the case, and NSPE will continue to provide updates regarding this litigation.

While the 2018 Gubernatorial and Congressional races are certainly important for Tennessee, I'd like to draw your attention to the races that should be top-of-mind for engineers. All 99 state House seats and half the Senate seats will

be on the ballot in November, and there is plenty of work to do before the 111th General Assembly convenes in January. For starters, 23 House members are not seeking reelection, including the Speaker of the House, Democratic Leader, Finance Committee Chair, and Finance Subcommittee Chair. 24 additional incumbents have opponents in the primary, and 62 face opposition in the general election. On the Senate side, where only half of members run each election cycle, there are three open seats. Of the 15 races with incumbents, 12 face opponents in either the primary or general election, or both. For those who don't want to do the math, of 132 legislators in the General Assembly, only 29 are guaranteed to be there in 2019.

Suffice it to say, it's time to step up our game. WE NEED YOUR HELP. The Tennessee Professional Engineers PAC is more important than ever. We have an opportunity to help keep our friends in office, and to boost the chances of success for candidates who are friendly to our profession. # Successful Session for Tennessee Engineers Priority Issues II Kasey Anderson - TSPE Executive Director

Tennessee engineers saw much success in the second session of the 110th General Assembly. TSPE followed 377 bills and played an active role in several dozen. We accomplished our goal in carrying legislation to strengthen Qualifications Based Selection, allowing the A/E board to provide guidance about QBS compliance, and had favorable outcomes in our efforts to protect utility companies and advocate for safe drinking water. We also successfully blocked and amended legislation that would have negatively affected our profession and/or the health, safety and welfare of the public related to the following: exemptions for mandatory sprinkler requirements, private purchase of utility districts, restrictions on smart meters, fluoride limits in public drinking water, apprenticeship programs, and changes to the permitting process for TDEC and other agencies.

Additionally, several exciting appropriations requests for which we advocated passed in this year's budget: \$3

million in recurring funds to Tennessee Tech College of Engineering, \$500,000 in continued grant funds to improve and maintain access to Tennessee's waterways, and an \$11 million earmark for the Energy Efficient Schools Initiative.

While TSPE provides your 'boots on the ground' at the Capitol every day, we are grateful for the many TSPE members who were involved in the legislative process by participating on our Government Affairs Committee, attending Engineers Day on the Hill, providing feedback on issues, and contacting legislators. I want to particularly recognize the efforts of David Brewer, chairman of the TSPE Government Affairs Committee. He is an outstanding leader for TSPE's efforts and is a huge part of our success. Thank you, Dave! In the coming months I will be doing Legislative Updates at local chapters across the state. There we will take a deeper dive into the outcomes from this session and what we see on the horizon. I hope you make plans to attend!
